On October 14th the WBBA will host the 1st Annual Sporting Clay Shoot at Wild Wing Sportsman’s Club located at N865 Hwy W in Campbellsport.

Registration will be from 11:30 – 1:00 with lunch being served.

We will start the 1st Round at 1:00p.m. followed by a break and anyone who would only like to shoot 1 Round can join us. The 2nd Round will start approximately at 2:30 and will be followed by a steak dinner.

Cost for lunch, 2 Rounds and steak dinner will be \$65.00 per person. 1 Round and dinner will be \$45.00 per person. \$5.00 of each entry will go into a scholarship fund to be given out by the WBBA. Anyone interested in just dinner can join us for a fee of \$16.00.
